GENERAL EXECUTIVE ORDER CREATING THE COVID-19 TASK FORCE

WHEREAS, Section 15, Article II of the 1987 Constitution states that “The State shall protect and promote the right to health of the people and instill health consciousness among them”;

WHEREAS, The Department of Health (DOH) has confirmed cases of local transmission of the Corona Virus Disease (Covid-19) in the Philippines;

WHEREAS, President Rodrigo R. Duterte has issued Proclamation No. 922 dated March 8, 2020 declaring the Philippines under a State of Public Health Emergency, requiring a whole-of-Government response and needing the efforts of government agencies and Local Government Units;

WHEREAS, COVID-19 cases are rising on a daily basis which necessitates the creation of an COVID-19 Task Force for implementation of aggressive measures and efforts towards prevention of and monitoring and reporting of these cases;

NOW, THEREFORE I, RICHARD I. GOMEZ, City Mayor of Ormoc, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Creation of the COVID-19 Task Force (C19TF) – The C19TF shall be composed of the following:
