The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R. A. 9184 and its Implementing Rules and Regulations (IRR).

The Procuring entity reserves the right to reject any and all bids declare a failure of bidding or not award the contract in any of the cases provided for in Section 41 of the IRR-A of RA 9184.
